

POLICIES/PROCEDURES

I _____ hereby certify that my dog(s) _____ qualify to participate in activities with "PAWS for Dogs, LLC".

1. _____ **Health and Pet Profile:**

I certify that my dog(s) is/are: in good health, up to date on all vaccinations (Rabies, Bordatella, and Distemper), has not been sick during the last month and is free from any communicable diseases. I agree to complete and turn in a PAWS for Dogs, LLC pet profile and a copy of my dog(s) veterinary vaccination records, to be included in my dog(s) permanent file at PAWS for Dogs, LLC.

2. _____ **Responsibility:**

I agree to provide the appropriate leashes, collars and tags for my pets and to keep them vaccinated and licensed. I am solely responsible for any harm my dog(s) cause to: another dog/PAWS for Dogs, LLC employees/guests/other dogs/equipment/or PAWS for Dogs, LLC property.

3. _____ **Representation:**

I recognize that PAWS for Dogs, LLC and their staff have agreed to accept my dog(s) for care based upon the information I provided in the required PAWS for Dogs, LLC pet profile and my dog(s) vaccination record(s). I am presenting my dog(s) to PAWS for Dogs, LLC as not having aggressive or threatening behavior. I further certify my dog(s) has/have not harmed himself /herself, another dog or any person.

4. _____ **Treatment and Reasonable Care:**

I understand there are inherent risks involved with my dog playing in open play areas, like a dog park, even when my dog(s) are constantly supervised. These inherent risks include but are not limited to: scratches, broken nails, sore or cut paws, puppy warts, kennel cough, and even behavioral problems.

In the event of any injury/or sickness involving my dog, it will be treated as deemed best by the staff of PAWS for Dogs, LLC within their sole discretion. I assume full financial responsibility for any and all expenses involved in my dogs extra care.

I understand that PAWS for Dogs, LLC is not a veterinarian and that if my dog(s) take multiple medications for any reason that I am enlisting the help of non-medical professionals to administer my dog(s) medicine(s), as best they can, following the discretion left for staff.

5. _____ **Right of Refusal:**

I understand that PAWS for Dogs, LLC has the right to reject a dog that: becomes aggressive, threatens to harm themselves/other dogs/staff/or guests, dogs with fleas or dogs believed to be too sick/old/or heavily medicated for our care, can be refused.

PAWS for Dogs, LLC can refuse service to clients who: become abusive with PAWS for Dogs, LLC staff, repetitively cancels their dogs requested service or do not show up for reservations on more than two occasions.

6. _____ **Photos, Videos and Recordings:**

I hereby give PAWS for Dogs, LLC full permission to use videos, photos, recordings, or any likeness of my dog(s) for any company materials without receiving any compensation for its use and without any disputes.

7. _____ **Fees and Payments:**

All PAWS for Dogs, LLC services are pre-paid or paid no later than drop off. Any unpaid balance of more than 30-days will result in PAWS for Dogs, LLC imposing a 5% interest charge per month until the unpaid balance is paid in full. If PAWS for Dogs, LLC pursues legal proceeding to collect unpaid fees, then PAWS for Dogs, LLC client will pay attorney's fees and cost related to collection, on behalf of PAWS for Dogs, LLC.

Fees will also be incurred if PAWS for Dogs, LLC employees have to stay late to clean and/or attend to problems with Dog(s) at drop-off.

8. _____ **Reservations and Refunds:**

Reservations are required. Each dog's spot is only guaranteed once payment is received in full. Boarding cancellations, specifically for the major United States holidays: (Thanksgiving, Christmas/New Year's, Easter and 4th of July), which are canceled within seven days of the boarding or holiday will receive a 50% refund. Please understand PAWS for Dogs, LLC relies heavily on no vacancy over these holidays.

9. _____ **Liability:**

I give permission for "PAWS for Dogs, LLC" representatives to enter my home/property for the agreed upon dates and times. I understand that leaving my pets unattended while away contains certain risks. PAWS for Dogs, LLC is not responsible for the safety of my home and pet(s) at times other than during the specific visits. I understand that the PAWS for Dogs, LLC representative is only required to complete the agreed upon tasks.

I agree that PAWS for Dogs, LLC and its staff will not be held liable for any behavioral problems, health problems, or injuries that may occur while my dog(s) is/are in the care of PAWS for Dogs, LLC. I release PAWS for Dogs, LLC from all claims of any kind.
